CONSENT AGREEMENT AND ORDER

Whereas, by the signatures of their counsel hereunder, Plaintiffs NATIONAL DEFENSE COMMITTEE, FULTON COUNTY REPUBLICAN PARTY and SEAN KILBANE, and Defendants FULTON COUNTY BOARD OF ELECTIONS AND REGISTRATION and RICHARD BARRON, in his official capacity as Elections Director of the Fulton County Board of Elections and Registration (collectively with Plaintiffs referred to as the “Parties”) have consented for the Court to enter the following Final Consent Agreement and Order as follows:

1.


At all times during which absentee ballot processes are taking place, Defendants shall allow credentialed monitors to view absentee and UOCAVA ballots, at least ten feet away from processing tables, inside the steel barriers, as they are processed pursuant to **State Elections Board Rule 183-1-14-0.9-.15(6), (7), (8) and (12)**; and

Defendants shall allow the credentialed monitors to observe the process of absentee ballot signature verification from the general public observation area consistent with O.C.G.A. § 21-2-406, O.C.G.A. §21-2-483(b), 183-1-14-0.9-.15(12), and the guidance of the Secretary of State in Official Election Bulletin dated December 9, 2020.

3. Defendants shall remove all blue-opaque-tri-fold barriers.


4. This is a limited issue and is not meant to any way amend or modify Georgia law. This Consent Order only pertains to the events surrounding the January 5th election.


